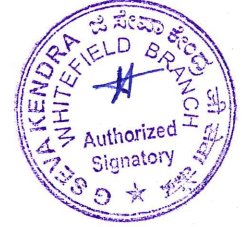

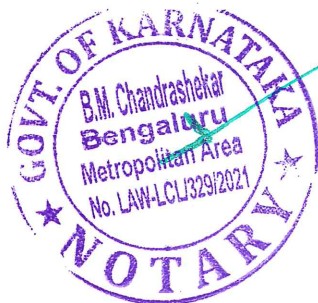
Statutory Alert:
